#### 豁免法律責任條款

本人同意 1) 參加“新唐人全世界中華傳統武術大賽”(以下簡稱“大賽”)不可能排除有受傷的危險; 2) 參加“大賽”的條件之一是本人將放棄向主辦團體以及他們的僱員、大賽機構、主管人員、經理以及教練(以下簡稱“受保機構”)對參賽中本人可能遭到的意外傷害或損失提出索賠。本人同意在參賽期間,如有損壞比賽場地,本人將承擔所有責任。3) 根據此“豁免法律責任條款”(以下簡稱“條款”),本人將永遠放棄、解除和豁免所有因為參加本次“大賽”而引起的法律糾紛和訴訟,無論是已經發生或將要發生的、已知或未知的。4) 簽署此條款,本人將承擔所有參賽的風險。

本人知道 2024 年 8 月在紐約舉辦的大賽會在哥倫比亞、台灣、德國和紐約進行初賽。本人將遵照主辦團體設立的比賽要求和規則。本人也不會在未經主辦團體同意的情況下撤出比賽。本人同意授權主辦團體在其商業廣告中使用本人的個人簡歷,所有參賽中的照片和錄像。本人保證所填寫的個人簡歷是屬實的。大賽過程中,本人有責任對簡歷中模糊和不正確的內容作出解釋和糾正。本人在條款上的簽名,說明本人除了認同條款內容之外不承認其他任何人的口頭或書面說明。本人同意此條款受美國紐約州法律範圍的制約和解釋。在此,本人聲明是參賽者並閱讀完條款的全文,理解並同意按條款要求執行(年齡在 18 歲以下的參賽者需監護人簽字)。

#### Waiver and Release Agreement

*I agree that 1) Participating in the "NTD International Traditional Chinese Martial Arts Competition" (hereinafter referred to as the "competition") cannot rule out the risk of injury; 2) One of the conditions for participating in the "competition" is that I will give up to the host organization, their employees, the competition organization, supervisors, managers, and coaches (hereinafter referred to as the "insured organization") file claims for accidental injury or loss that may occur during the competition. I agree that during the competition if there is any damage to the competition venue, I will bear all the responsibility. 3) According to this "Exemption from Legal Liability Clause" (hereinafter referred to as the "Terms"), I will forever waive, release and exempt all legal disputes and lawsuits caused by participating in this competition, whether it has occurred or will happen, known or unknown. 4) By signing this clause, I will bear all the risks of participating in the competition.*

*I know that the competition to be held in New York in August 2024 will be held after preliminaries in Columbia, Taiwan, Germany, and New York. I will abide by the competition requirements and rules set by the host organization. I will not withdraw from the competition without the consent of the host organization. I agree to authorize the host organization to use my resume, all photos, and videos in the competition. I certify that the resume I filled out is true. During the competition, I have the responsibility to explain and correct the vague and incorrect content in the resume. My signature on the terms indicates that I do not acknowledge the oral or written explanations of anyone other than the content of the terms. I agree that this clause is subject to the restrictions and interpretation of the laws of the State of New York, USA. Here, I declare that I am a participant and have read the full text of the terms, and I understand and agree to implement the terms. (Participants under the age of 18 need to obtain the signature of their parent or guardian)*
